

The Entry Level MSN program is approved by the Minnesota Board of Nursing as a licensure-preparing program leading to a master's degree. Graduates of the program who pass the NCLEX licensure exam are eligible to apply for public health nurse registration.

The program is endorsed by the American Holistic Nurses Credentialing Corporation (AHNCC). Graduates are prepared to provide holistic nursing care as defined by the American Holistic Nurses Association's scope and standards of practice. Graduates who successfully earn RN licensure can waive the 1 year of holistic nursing practice and the holistic continuing education contact hours to sit for holistic nurse certification if the exam is taken within 2 years of graduation.

Nursing Simulation and Learning Laboratory

Skills lab sessions may be scheduled weekly to apply theoretical content and demonstrate nursing skills and related concepts and principles. Practicum labs are coordinated by nursing faculty and are directly aligned with concurrent theory classes. **Students are encouraged to spend time each week in the nursing lab during open lab hours in addition to scheduled skills lab sessions.** A schedule of open lab hours will be posted weekly online. A Nursing lab coordinator is available during open lab sessions to reinforce practice and answer questions. General Information

Technology Requirements and Expectations

Nursing programs at Metropolitan State University utilize a combination of traditional face-to-face classroom courses, online courses, and hybrid courses. Options for accessing computers include the student's own device, laptop check-out from the university library, or accessing computer workstations in the university library, student center, or public libraries. A built in webcam/microphone or external USB webcam/microphone is required for all courses with an online component where zoom is used in the course. A headset is recommended for course activities.

For all courses in the ELMSN program, students must have reliable internet access to log into the D2L system, recommended to be done at least four days per week to check for course updates and complete required work. Students can access the WiFi on campus using a personal device or via the computers at the University or public library. The ability to navigate the internet for research, course assignments, and university resources is required. Competence in using Microsoft Office products such as Word and PowerPoint is also required.

Other skills students must possess include the ability to add browser plug-ins for viewing files and content presented within the course or be able to get such assistance from non-campus sources. Additional skills include intermediate or higher-level skills at file management (ability to create folders, move and rename folders and files, identify type of file by its file-extension, attach files to emails, etc.).

Updated virus scanning software for files sent and received (such as McAfee Antivirus, Norton Internet Security, etc.) is required.

Course Delivery Methods

The Entry Level MSN Program utilizes multiple course delivery methods including face-to-face, hybrid, Hyflex and online.

- Face-to-face courses are offered in the traditional classroom setting on campus. A face-to-face course may be web-supported. For example, the syllabus, course handouts, and announcements can be accessed online.
- Blended-hybrid courses utilize a mix of face-to-face classroom sessions with online work. Each semester, hybrid nursing courses are found in the class schedule under Nursing Courses with a note indicating the course is a blended-hybrid course.
- Hyflex courses allow students to select between synchronous delivery where students and instructor(s) meet on camera together over the Zoom video communications system or attending face-to-face.
- Online courses are delivered either entirely via the Internet or with a maximum of 1-2 face-to-face sessions. Due to recent restrictions as a result of the COVID-19 pandemic, some nursing courses have been converted to a totally online delivery format. These have taken different forms, from asynchronous delivery to synchronous delivery where students and instructor(s) meet on camera together over the Zoom video communications system. All Metropolitan State students have zoom access to participate in courses and to host meetings. Note: Online courses in the College of Nursing and Health Sciences are NOT independent study courses.

Employment

Because of the very rigorous demands of meeting requirement for the Entry Level MSN nursing program, it is advised that students limit work schedules to very casual, flexible, part-time employment.

Name and/or Address Change

Students who have legally changed their name must present legal proof of this change within two weeks following the date of the legal action to Admissions and Records or online at <https://www.metrostate.edu/sites/default/files/2020-11/name-SSN-change-Nov2020.pdf> and to the Academic Advisor. Additionally, inform **both** the records office and your advisor of any address change.

Registration for Registered Nurse Licensure

In the last semester of the program, students complete an application to the Minnesota Board of Nursing for the Registered Nurse licensing examination. Upon receipt of approval by the Minnesota Board of Nursing, students are eligible to take the NCLEX-RN licensing exam. More information will be provided during the last semester of the program.

Assessment Technologies Institute (ATI) is a learning platform that will be utilized by students throughout the program to prepare for the NCLEX-RN examination. ATI is an innovative testing and review program that is linked to specific courses each semester. The modules in the program combine content mastery assessment with review questions and standardized testing. After reviewing assigned content, students will take both non-proctored and proctored exams to determine their level of mastery of content. Assessment, review, and examinations are designed in accordance with the NCLEX test plan. To pay for this program, fees will be attached to a specific course during 3 semesters of the program. Linking the payment to specific courses allows for the use of financial aid to cover this cost. The program is comprised of several resources, including the following nursing areas:

These resources may be assigned or used independently. Students will be required to complete proctored exams [Content Mastery Exams (CMEs)] designed to assess the student's mastery of content in certain specific areas listed above. During the last semester of the program, the RN Comprehensive Predictor will be administered. The Comprehensive Predictor is an assessment designed to assess the student's comprehensive knowledge base prior to graduation. The CMEs are predictive of the overall score on the RN Comprehensive Predictor. Performance on the Comprehensive Predictor is 96% predictive of outcomes on the NCLEX-RN. **Students are encouraged to utilize and review the content and products consistently throughout the program as an adjunct to course content.**

A task force of representatives from nursing education in Minnesota developed these Technical Standards. Educational institutions represented were: Bemidji State University, The College of St. Scholastica, Lake Superior College, Itasca Community College, Rainy River Community College, Mesabi Range Community and Technical College, Hibbing Community College, and Riverland Community and Technical College. Adaptations were made from the Core Performance Standards of the University of Arizona, Minnesota West Practical Nursing Program, and Iowa Community Colleges.

Clinical Practicum Requirements

Legal contracts are arranged with clinical and practicum sites. These contracts specify information that the college is required to collect from students. **Communication regarding all pre-practicum documentation and how to submit it will come via your Metro State email or on your D2L Advising Site from the Department of Nursing.** Students must submit the required pre-practicum documentation prior to the deadline. Failure to submit this information prior to the deadline will result in students' inability to enroll and attend clinical courses. All requirements must remain valid for the duration of all clinical and practicum experiences and may have to be updated throughout the program. It is the student's responsibility to maintain records of meeting these requirements and upload records to an online platform.

To continue in the nursing program, students **must document AND remain current** with all pre-practicum requirements, such as immunizations, HIPAA Training, CPR Certification, etc. Students should review these requirements and ensure plenty of time for completion. Courses that have internships, fieldwork, clinical or practicum components require students to complete a background study through the Department of Human Services (DHS). The current background study requires a government photo ID and a mandatory finger printing process. Students will be required to pay the fee required by DHS for the background study, and an additional fee to the fingerprinting vendor. **Students will be prompted to complete a background study prior to their practicum/clinical via their Metro State email from CNHS, the D2L course site or by their instructor; do not obtain a background study without receiving a prompt from CNHS.** Students will then complete an online application for the background study and go to one of the many locations for fingerprinting within 14 days of submitting the background study online application. This background study can be transferred to an employer after graduation. Fingerprinting will improve the turnaround time of the background study and will provide more accurate records when searching for criminal history. There is nothing you need to do at this time other than be aware of this background study requirement.

If you have a current background study with your employer using this new background study process, you will not have to be fingerprinted again but there is a separate process for transferring that study to the university.

Health Care Services and Health Insurance

OnCare, the telehealth platform previously utilized by Metropolitan State University, is no longer in service. The Counseling, Health and Wellness Department is undergoing the process of identifying and establishing a contract with a new telehealth vendor to serve our students.

In the interim, Counseling, Health and Wellness staff members are providing health coaching and case management services for Metropolitan State University students on an individual basis. Staff can help students by facilitating referrals, connecting them with local resources, and meeting one-on-one as appropriate.

For individualized health and wellness support, please contact Rachael Mills, Coordinator of Health and Wellness to set up a meeting (via phone or Zoom).

This service is provided in compliance with Minnesota Law (State Statute 136.F20 Student Health), which requires all four-year institutions in the Minnesota State System to provide health care services for students.

These services are limited, however, so nursing students are strongly encouraged to carry a personal health insurance policy.

Dress Code for Clinical and Simulation Experiences and Non-Patient Care Activities

Nursing uniforms are required whenever students are in healthcare facilities for clinicals or simulation. They may be recommended in lab per individual instructors.

Scrubs, Skirt and Jacket

The official ELMSN uniform includes a royal blue scrub top and pewter uniform pants. A gray skirt may be substituted for pants with legs having some type of opaque covering (pants, hose, etc..) in a color that matches the skirt. Skirts must be to the middle of the knee or below. Students may wear a white, gray or royal blue shirt under the royal blue scrub top. A royal blue uniform jacket may be worn over the scrub top. No street clothes can be worn over the uniform (hooded sweatshirts, fleece jackets, neck scarves). Uniforms are required to be clean and laundered after each use to reduce risk of transmission of pathogens and associated infections.

Footwear

Footwear must be closed-toe and closed-heel, clean, and primarily solid in color (gray, black, tan, white, blue). Athletic shoes are recommended with non-skid soles. Sandals are not allowed.

Approved Head Covering

A head-scarf may be worn for religious reasons, and must be clean, a solid color coordinated with the uniform, not longer than mid-torso front and back and be worn close to the body (not billowing). In restricted and semi-restricted areas (such as in the Operating Room area) the head scarf must be tucked into the scrub shirt and covered with a disposable head covering, such as a surgical hood. The disposable head covering must cover the scarf while in the restricted area. No hats, bandanas, sweat bands, or other types of head coverings may be worn unless required for medical, safety or religious reasons.

College Patch and ID Badge

The student must have a college patch sewn to the upper left shoulder of the uniform top and jacket and wear a Metropolitan State University photo ID badge. Individual pictures will be taken at no charge early in your first semester for the Metropolitan State University photo ID badge. Students **MUST** wear their school photo ID badge clipped near the neckline at all times while in a clinical facility.

Hair and Nails

Hair length past the collar must be caught with an appropriate clip or band at the back of the neck as long as the hair is not long enough to hang forward over the shoulder. Otherwise, long hair must be won up on the head. Hair must have a neat professional appearance. Moustaches, beards and sideburns must be kept neatly trimmed. Fingernails should be short (no longer than 1/8 inch), clean and without polish. No artificial nails are allowed.

Perfume, Scent or Body Products with Fragrance

No scented products shall be worn in clinical settings.

Jewelry/Body Art

Accessories (e.g., necklaces, bracelets, earrings, other piercings, buttons, pins, stickers) must be kept to a minimum and worn in a way that prevents contamination and does not present a safety hazard. In addition, they must be appropriate in nature and not cover your ID badge. Tattoos and other body art that do not pose a conflict with the job or environment is permitted as long as it is not offensive to patients or colleagues based on racial, sexual, religious, ethnic or characteristics or attributes of a sensitive or legally protected nature.

Non-Patient Care Activities

Students may wear the uniform jacket with their Metropolitan State University photo ID badge over professional street clothes for pre-clinical preparation and other non-patient care activities. Jeans are not allowed under a warm-up jacket and closed-toe shoes (no sandals) must be worn. Metropolitan State University photo ID badge must be worn and visible at all times.

While on duty, students must observe these dress code regulations at all times. Individual faculty will give students required modifications for specialty areas.

Other Required Materials for Clinical Experience

All students are required to have the following items with them for every clinical experience, plus any materials specified by faculty:

1. Watch with a second hand
2. Stethoscope
3. COVID-19 has necessitated additional required personal protective materials specific to each clinical site.

Consequences for non-adherence to the dress code or coming to clinical unprepared or late may include being sent home from clinical, a requirement to make up missed clinical, and potential grade consequences such as a reduced grade or failure of the course. See practicum course syllabi for additional detail.

Standards for Professional Behavior

Expectations

Metropolitan State University partners with hospitals, long-term care facilities, clinics, public health agencies, school health services, and other community-based organizations to offer optimal clinical experiences for students. The university establishes clinical-use contracts with each facility that stipulates mutual expectations for both services and regulations. Students are required to represent Metropolitan State favorably, in both professional attire and performance, while in an affiliating clinical facility. Failure to demonstrate professional behaviors in a clinical site may result in consequences, including being sent home from clinical, requirements to make up missed clinical or complete an alternate assignment, failure of an assignment, and/or failure of a course.

A variety of experiences may be utilized by faculty to meet course objectives. Such experiences may include, but not be limited to, independent learning projects and alternative time schedules. Students will be expected to provide nursing care for clients of all genders and sexual identities with a variety of medical and psychosocial conditions. Students should be prepared to accommodate alternative learning assignments and possible evening and night clinical experiences if deemed necessary by the faculty. Appropriate notification will be given.

Students are permitted in the health care setting only during clinical hours and specified preparation hours. Friends or family members, including children, are not allowed at the pre-clinical preparation or during clinicals. Arrangements for travel to clinical facilities and any costs associated with medical care, travel, meals, parking, and lodging are the sole responsibility of the student.
